Excel in Career Technical Education (CTE) Fees

Summary

Per statute (K.S.A. 72-3810), the Kansas Board of Regents shall establish general guidelines for tuition and fee schedules in career technical education courses and programs. The Excel in CTE tuition and fee schedule of every technical education program shall be subject to annual approval.

Background

K.S.A 72-3810 states:

“All tuition and fees charged for career technical education by any board shall be in such amounts as are authorized by rules and regulations adopted by the state board which shall establish general guidelines for tuition and fee schedules in career technical education courses and programs. The particular tuition and fee schedule of every career technical education program shall be subject to annual approval of the state board. A current complete schedule of tuition and fees for each career technical education course and program of each board as approved by the state board shall be maintained on file in the office of the state board and shall be open for public inspection at any reasonable time.”

"Fees means those charges assessed against a student by a community college, technical college or the institute of technology for student services, such as health clinics, athletic activities and technology services, or for books, supplies or other materials necessary for a particular course or program, the expense of which is not covered by tuition.”

"Tuition means those charges assessed against a student by a community college, technical college or the institute of technology on a per credit hour, per course or per term basis, and that are charged to cover the general expense of providing instructional services.”

As per the Postsecondary Technical Education Authority’s (TEA) request, on Thursday, December 19, 2019, representatives from community colleges, technical colleges, and Board staff met to set guidelines for fees associated with Excel in CTE courses and programs. As a result of this meeting, agreed upon allowable fees include items/services students take with them and industry-specific fees required for entrance/acceptance into the program.

Allowable fees include:

- Uniforms
- Personal protective equipment
- Background checks
- Fingerprints
- Drug tests
- E-subscriptions/E-books
- Textbooks
- Certification tests
- Liability insurance (example: student malpractice)
- Graduation fees (if applicable)
- Transcript fees (if applicable)

Unallowable fees include:

- Student fees (general)
- Technology fees
- Health fees
- Consumables
- Any other fee not on the allowable list

Non-tiered courses - per statute (K.S.A. 71-1802) a technical program is defined as a “program of study comprised of a sequence of tiered technical courses and non-tiered courses, which is identified by the state board as a technical program for funding purposes.” For this reason, students enrolled in technical programs may take non-tiered courses and are responsible for all associated tuition and fees.

In early January 2020 a data request was sent to each community and technical college asking for all technical programs and associated fees charged to Excel in CTE students. The following tables include a listing of all Excel in CTE fees charged by colleges for each program. Allowable fees are highlighted in green and totals are provided for the TEA’s consideration.

Preface

Washburn Institute of Technology has three standard fees associated to all Excel in CTE technical programs:

- Transcript Fee (\$5)
- Graduation Fee (\$50) – one-time program enrollment fee to secure the student is going to attend

Institution states the following:

1. Most all of the textbooks utilized by Washburn Tech are a part of the whole program. Some are tied to courses, but in general, students use them for various courses, even spanning semesters. Furthermore, Washburn Tech follows the Washburn University textbook adoption process. The textbook adoption for the Fall 2020 semester does not begin until April 2020. The textbooks listed for each of the programs are the general estimated costs assuming there are not major changes to the programs themselves, nor the textbooks used in the future.
2. You will see both OSHA 10 and OSHA 30 tied to various courses. If OSHA is taught as a specific credit hour, it is tied to the course, but if it is taught as part of the program, it simply shows “program.” Some of the programs have an opt-in to take OSHA for the students, so it is listed as program, but some students may choose not to take it.
3. The Bring Your “A” Game is handled very similar to OSHA. Generally, this offering is tied to a Workplace Skills/Ethics course (non-tiered), but in this situation, they are tied to the program as it is taught during the program. You will see two different amounts. Some programs utilize the Strengths Finder Quiz (\$12), the Bring Your “A” Game workbook (\$8), and some do both. You will see \$8, \$12, or \$20.
4. Like other schools, most of the PPE is a general amount and will vary based upon what the program requires. We have used standard/general amounts for safety glasses, gloves, steeled toe boots, and hard hats. Unless these are provided in a PPE Kit, students are expected to bring their own to glass from the list provided by instructors at New Student Orientation.
5. Many of the programs have specific projects they build and keep. In this situation, each project is listed, and the associated course is listed as well. Students build and take these home.
