APPROVAL OF MINUTES

UPDATES

A. Transfer and Articulation Council (TAAC) update was provided by Jon Marshall, Allen CC.

During the March 6th meeting, several institutions submitted courses for approval for System Wide transfer. TAAC also finalized the list of courses for the 2019 Kansas Core Outcome Group (KCOG) conference:

Two Dimension Design Three Dimension Design Voice and Diction Piano I Stage Makeup

Aural Skills I Aural Skills II Introduction to Exercise Science
Principles of Management Creative Writing Old and/or New Testament

Faculty will review the core outcomes for the following courses:

Introduction to Drawing Interpersonal Communication Nutrition

Trigonometry World History to 1500 World History 1500 to Present

World/Comparative Religions Descriptive Astronomy with Lab, Lecture, and Lab

OTHER MATTERS

A. Reverse Transfer Update was presented by Samantha Christy-Dangermond.

During AY2015 through AY2018, 2,250 students opted in to Reverse Transfer. Of those students, 723 students received a degree that can be attributed to Reverse Transfer.

Last fall universities were asked to partner with a community college for reverse transfer. Those partnerships are as follows:

- Emporia State University with Hutchinson Community College
- Fort Hays State University with Barton Community College
- Kansas State University with Highland Community College
- University of Kansas with Johnson County Community College
- Wichita State University with Butler Community College
- Washburn University with Allen Community College
- Pittsburg State University with Fort Scott Community College, Allen Community College, Neosho County Community College and Coffeyville Community College

During AY2018, over 1,500 transcripts were sent by universities and degree audits were conducted manually by the twoyear institutions, resulting awarding 203 reverse transfer degrees to the students.

B. Karla Wiscombe updated SCOCAO on the Concurrent Enrollment Partnership (CEP) Report for AY 2018. KBOR Data Research and Reporting staff worked hard to prepare the data tables in the CEP Report. CEP is defined in Board policy as an agreement between a district and postsecondary institution in which a high school faculty member teaches a college-level course to high school students during the regular high school day. The CEP report summarizes CEP course enrollments by headcount and credit hours for all CEP courses. Additional information is provided for System Wide Transfer (SWT) courses offered through CEP and the successful completion rates of SWT courses. Table 6 presents the percentage of qualified faculty teaching SWT courses offered as CEP.

SCOCAO thanked Karla for the informative report.

- C. Max Fridell informed SCOCAO of the July 1st deadline for submitting AY2018 Performance Reports. Information will be sent to the institutions in April. Thank you in advance for your hard work on completing these reports.
- D. Performance Agreements update provided by Jean Redeker.

The current performance agreements are for AY2017-2019. The Board's strategic plan ends in 2020, and the Board is in the process of developing the state's next strategic plan for higher education. The timeline for approval of the new strategic plan and the timeline for the development of new performance agreements are not the same. "Bridge" agreements to cover the gap will need to be developed.

Staff proposes reconvening the Performance Agreement Working Group formed in December 2016 by the System Council of Presidents. The Working Group consisted of members from Kansas State University, North Central Kansas Technical College, Johnson County Community College, Hutchinson Community College, Flint Hills Technical College, Pittsburg State University, and Washburn University. The Working Group would be charged with making recommendations for "bridge" agreements and reporting to SCOCAO in May 2019 with those recommendations.

Discussion was held, and the consensus was to reconvene the Performance Agreement Working Group. SCOCAO looks forward to hearing their recommendation in May.

E. Open Educational Resources(OER) Update presented by Jean Redeker.

The Student Advisory Committee and Midwestern Higher Education Compact (MHEC) group are working on OER independently. The groups are merging together to develop an OER Steering Committee for the state. The OER Steering Committee will work on various aspects including, but not limited to: promoting OER, determining monetary availability, best practices, and assisting the OER champion at the institution. The expectation is to have the new group structure in place by June.

Discussion included national OER events and the inclusion of committees currently discussing OER.

F. Additional programs for Midwest Student Exchange Program was presented by Charles Taber, KSU. KSU has worked on its out-of-state recruitment and removed the program restriction for undergraduate students who participate in the Midwest Student Exchange Program (MSEP). Now students from all majors and programs are welcome through the MSEP.

Concurrent Enrollment Partnership Report for Academic Year 2018

Summary

Participation in Concurrent Enrollment Partnerships (CEP) has consistently grown in Kansas since the creation in 1993 by state statute. While various forms of dual enrollment are available to high school students to earn college credit, Board policy applies only to Concurrent Enrollment Partnerships (CEP). CEP is defined in Board policy as an agreement between a district and postsecondary institution in which a high school faculty member teaches a college-level course to high school students during the regular high school day. The Concurrent Enrollment Report for AY 2018 (fall 2017 & spring 2018) summarizes CEP course enrollments by headcount and credit hours for all CEP courses and then examines the subset of System Wide Transfer (SWT) courses offered through CEP. Additional information is provided on the successful completion rates of SWT courses offered as CEP as well as the percentage of qualified faculty teaching those courses. 3/20/2019

Background

Concurrent Enrollment Partnerships began as part of the 1993 Kansas Challenge to Secondary School Pupils Act (K.S.A. 72-11a1-05) with the purpose and intention to "provide a means whereby school districts in cooperation with institutions of postsecondary education may provide new and exciting challenges to secondary pupils by encouraging them to take full advantage of the wealth of postsecondary education opportunities in this state."

Board policy requires the establishment of an agreement between the postsecondary institution and the district summarizing the liaisons, curriculum, student assessment, awarding of credit, compensation and qualifications of faculty, and a process to review the agreement at least every five years. CEP courses may be tiered and non-tiered, but faculty must attain the instructional eligibility established by the regional accrediting body.

In 2013, the Higher Learning Commission (HLC), the accrediting body for all 32 system institutions, clarified criteria regarding the qualifications of faculty. By September 1, 2017, HLC required faculty teaching general education courses to hold a master's degree or higher in the discipline or subfield relevant to what they teach, or a master's degree in any subject area and 18 graduate credit hours in a discipline or subfield relevant to what they teach. Twenty-one KBOR institutions received an approved waiver from HLC which extended the deadline for meeting faculty qualifications until September 1, 2022. Institutions with approved waivers are indicated in Table 6 by an asterisk.

Data on Concurrent Enrollment Partnerships

This report includes data submitted by institutions via the Kansas Higher Education Data System (KHEDS). CEP reports include data from all CEP courses, technical and non-technical, taught by high school faculty during the regular high school day. Information for all CEP courses is outlined in Tables 1 and 2 with subsets of System Wide Transfer (SWT) courses summarized in Tables 3-6.

Table 1 displays a six-year trend for the number of students taking at least one CEP course from AY 2013 through AY 2018, indicating 35.4% growth of student participation within that timeframe for the system.

Table 2 displays a six-year trend for the number of credit hours awarded from all CEP courses from AY 2013 through AY 2018, indicating 30.7% growth in credit hours within that timeframe for the system.

Table 3 provides the headcount and credit hours for only the System Wide Transfer (SWT) courses offered through CEP. SWT-CEP courses were taken by 15,120 high school students, which constitutes 81% of the total headcount (18,641) of all CEP courses taken in AY 2018. The 98,530 credit hours awarded for SWT-CEP courses in AY 2018 is 81% of the total credit hours (121,176) for all CEP courses.

Table 4 outlines the pass rate of SWT-CEP courses by institution, indicating a systemwide pass rate of 96.9% for all SWT-CEP courses.

Table 5 takes an even closer look at the pass rate of SWT-CEP courses and provides pass rates for individual courses.

Table 6 outlines the number of HLC qualified and non-qualified high school faculty, who taught SWT-CEP courses in AY 2018 for each institution. Every sector increased the number of HLC qualified faculty and the system increased the percentage of qualified faculty teaching SWT-CEP courses by 5%.
