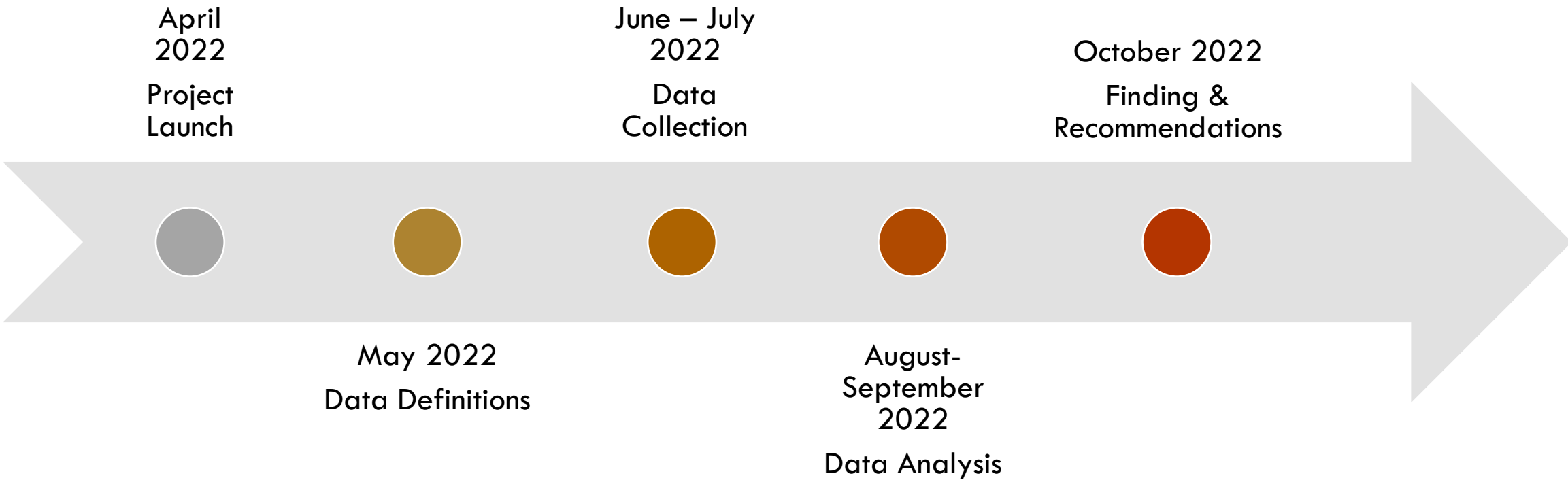
Faculty Advisory Group Role
